

## TOWN OF LAFAYETTE

### AUTHORIZING EAST TROY FIRE DEPARTMENT TO HOLD VOLUNTEER FUNDS

#### ORDINANCE 3 - 04

The Town Board of the Town of LaFayette, Walworth County, Wisconsin, does hereby ordain as follows:

#### SECTION 1.0 PURPOSE AND AUTHORITY

The purpose of this ordinance is enacted pursuant to the authority of § 66.0608, WI Statutes, for the purpose of authorizing "volunteer funds" to be held in the name of the East Troy Fire Department. This ordinance is to be interpreted in conformance with that section as it may be amended from time to time.

#### SECTION 2.0 ADOPTION OF ORDINANCE

The Town Board of the Town of LaFayette, Walworth County, Wisconsin, does hereby authorize the East Troy Fire Chief to deposit volunteer funds of the department in an account in the name of the fire department in any public depository.

#### SECTION 3.0 CONTROL OF FUNDS

The fire department, through its Fire Chief, is granted exclusive control over the expenditure of funds of the department. This authority is granted without limitation as to amount or type of funds. It is subject to the limitations and requirements herein set forth.

#### SECTION 4.0 LIMITATIONS AND REQUIREMENTS

The following limitations and requirements shall apply to the handling and disbursement of funds from the account:

- A. **Expenditures.** Expenditures withdrawn from the account may be made only upon majority vote of Fire Department members present at a duly noticed meeting of the Department. Such withdrawals and expenditures may be made for any purpose that promotes the ability of the Fire Department to provide services for which it is organized.
- B. **Accounting.** The Fire Chief shall provide the Town Board with quarterly statements at the end of March, June, September and December of each calendar year. The statements shall be provided within thirty (30) days of the end of the calendar quarter. The statements shall include a detailed itemization of all receipts, expenditures and the balance on hand at the end of the quarter. The source of all funds and the identity of the payee for each disbursement shall be set forth.
- C. **Audit.** East Troy Fire Department accounts shall be included in the annual audit of the East Troy Area Emergency Services District funds. They shall be audited in the same manner as other East Troy Area Emergency Services District funds.

#### SECTION 5.0 SEVERABILITY

If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, the invalidity or unconstitutionality shall not

affect the provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision of this application.

**SECTION 6.0 REPEAL OF INCONSISTENT ORDINANCES**

All existing Town of LaFayette, County of Walworth, ordinances, parts of ordinances and amendments thereto in conflict with any of the provisions of this ordinance are hereby repealed.

**SECTION 7.0 EFFECTIVE DATE**

This Ordinance shall be effective the day after its posting in three (3) public places within the Town of LaFayette.
