RESOLUTION #8 - 2014

FEES FOR DOG LICENSING

WHEREAS, the Town of LaFayette has determined that in order to promote and protect the health, safety and welfare of the members of the Town that dogs and kennels need to be licensed; and

WHEREAS, the Town of LaFayette has enacted Ordinance 10 - 06 Dog Licensing pursuant to the authority set forth in § 174.05 to 174.10 WI Statutes; and

WHEREAS, the Town Board has determined that it is necessary to charge fees for said licenses; and

WHEREAS, on October 14, 2009, the Town of LaFayette passed a Resolution setting the fees for Dog and Kennel Licensing within the Town of LaFayette; and

WHEREAS on October 20, 2012, the Town passed a subsequent Resolution increasing and setting the fees for said licenses within the Town of LaFayette due to an increase set by the County for their portion of each license; and

WHEREAS, the County increased the County's portion of the dog licensing fees incrementally over the next five (5) years; and

WHEREAS, the Town Board will increase fees so as not to unduly cost the Towns' tax dollars to be spent making up any difference due to the County's portion of the entire fee; and

NOW, THEREFORE, BE IT RESOLVED as follows:

Fees shall be set annually and incrementally increased through 2019 for the Town of LaFayette, as follows:

- 1. Spayed and neutered dogs are also known as altered dogs.
- 2. Unaltered dogs are also known as unsprayed and unneutered dogs.
- 3. Late fees, as set statutorily as April 1st, for each dog shall be set at five (\$5) dollars annually.

- 4. Transfer fees for each dog shall be set at five (\$5) dollars annually.
- 5. Multiple dog fees, as defined in § 174.053(1), WI State Statutes, also known as multi-dog fees, shall be set at thirty-five (\$35) dollars for up to the first twelve tags and three (\$3) dollars thereafter for each additional multi-dog tag issued annually.

AND, BE IT FURTHER RESOLVED that the Town Board of Supervisors of the Town of LaFayette, County of Walworth, maintain that these fees shall be set for dog and multi-dog licensing within the Town of LaFayette at the issuance of the 2015 dog tags until replaced by any future resolution.
