

**RESOLUTION # 5 - 2021**

**RESOLUTION ADOPTING REVISED WARDS**

**WHEREAS**, all cities, villages and towns with a population of 1,000 or more must establish municipal wards based on the results of the decennial federal census of population as required in § 5.15, WI Statutes; and

**WHEREAS**, each County Board must adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan, dividing the county into districts and designating the approximate location and population of each ward proposed to effectuate the division of the county into districts as required in § 59.10(3)(b), WI Statutes; and

**WHEREAS**, all cities, villages and towns will subsequently make adjustments, if necessary, to their ward boundaries based on the requirements in § 5.15(3)(b), WI Statutes; and

**WHEREAS**, these laws require the governing body of each municipality, within sixty (60) days upon receipt of the adopted tentative supervisory redistrict plan, to create election wards or adjust existing ward lines to accommodate the creation of supervisory districts and to number each ward accordingly by consecutive whole number beginning with the number one (1) through adoption of a resolution; and

**WHEREAS**, municipalities must report the establishment or adjustment of ward lines to the county clerk within five (5) days of passing said resolution and the Wisconsin State Legislative Reference Bureau (if population is over 10,000); and

**WHEREAS**, Walworth County has provided the Town of LaFayette a tentative county supervisory district plan subsequent to the 2020 decennial federal census completion encompassing the entire geographical area of the Town of LaFayette; and

**WHEREAS**, the total population for the Town of LaFayette, County of Walworth, State of Wisconsin, as determined by the 2020 federal decennial census is 2039.

**NOW THEREFORE, BE IT HEREBY RESOLVED** the Town Board of the Town of LaFayette, pursuant to § 5.15, WI Statutes, adjusts the existing ward lines within the Town of LaFayette and adopts the wards described as follows:



These wards hereby created in this Resolution become effective for elections held after December 31, 2021, provided, however, that implementation of this Resolution is contingent upon approval by the Walworth County Board of Supervisors of a county-wide supervisory district plan based upon the foregoing election wards.
